A Million Thanks Armed Forces Children's Education Fund. Inc. QUALIFICATIONS FOR AFCEF SCHOLARSHIP FUNDS:

The candidate must be a surviving child of a U.S. Military Service Member who lost their life on or after October 7, 2001, while serving their country. The candidate must be enrolled (or accepted) at an eligible educational institution (college, university or accepted trade school) that meets federal accreditation standards. Be able to prove financial need of funds. Submit completed AFCEF application and 500 word essay titled, "Why it is important for me to continue my education, and what the plan is for my life."

Applications are ONLY accepted between 1 January – 31 March and 1 July - 15 October of each year. AFCEF funds are available based on need, not grades, and will be decided on a case-by-case basis. AFCEF funds are secondary to other funding sources and payment will be made directly to the school. A submission of an application does not guarantee an AFCEF Scholarship. The Society awards a minimum of ten \$5,000 merit-based scholarships to incoming freshman who have completed both phases of the **General Henry H. Arnold Education Grant application**, and therefore, have already been reviewed for eligibility and had their Grade Point Average (GPA) verified. American Legion Legacy Scholarship

The American Legion offers a Legacy Scholarship to children whose parents(s) died while on active duty orders on or after September 11, 2001. The parent does not have to have been in combat, or even "in country". Being on active duty is the only stipulation. This includes any National Guard (air or ground), and reservists who have been activated by federal orders. Applications must be post marked no later than 1 April 16. The scholarship is not "competitive" meaning that all who correctly and fully complete the application process will be awarded the scholarship. The amount distributed to the applicants will vary year-to-year based on the amounts of donations and awarded scholarships. Applicants must be a high school senior or high school graduate to apply. Scholarship is for undergraduate study at an accredited institution of higher education within the U.S. For further information and an application, call the Program Coordinator at (317) 630-1212 or go to:

<u>Armed Forces Benefits Association (AFBA) Charles C. Blanton Family Survivor College Scholarship Program</u>

The AFBA offers the Charles C. Blanton AFBA Family Survivor College Scholarship. The scholarship is offered to the surviving spouse or children of an insured AFBA member who dies in a combat zone, as a result of combat action or whose life was lost as a result of acts of foreign or domestic terrorism. The scholarship provides an educational scholarship to candidates for an undergraduate degree of up to\$10,000 per family, per year for a maximum benefit of \$40,000 for tuition and fees. Army Emergency Relief (AER)

AER is a private non-profit organization whose mission is to provide financial assistance to Army Soldiers and their dependents in time of valid emergency need. Their education program is a secondary mission to help Army families with the costs of education. AER offers three scholarships: Stateside Spouses Education Assistance Program, Overseas Spouse Education Assistance Program and the Major General James Ursano Scholarship Fund (for dependent children). Army Scholarship Foundation (ASF)

The Army Scholarship Foundation awards one-year financial scholarships (not grants or loans) on an annual basis to qualified and deserving students. The amount of award ranges from \$500 to \$2000 for undergraduate studies at accredited educational/technical institutions. Scholarship recipients may apply to renew their scholarships annually for a total of four years of higher education. Renewal is not automatic, but depends on academic performance and continued academic eligibility. Scholarships are awarded on the basis of academic record and participation in school and community activities.

Army Women's Foundation - Legacy Scholarship

The Foundation's Legacy Scholarship program recognizes the importance of education and helping recipients to achieve their educational goals. The Legacy Scholarship Program offers financial support in four areas: Certificate programs, Community College coursework, Undergraduate Degrees, and Graduate Degrees. Scholarships are awarded only for coursework from accredited institutions. Scholarships are based on merit, academic potential, community service, letters of recommendation, and need.

Applicant must be a woman who has served or is serving honorably in the U.S. Army, U.S. Army Reserve, Army National Guard or the child of a woman who served honorably in the U.S. Army, U.S. Army Reserve or Army National Guard.

Assisting Single Parents in Realizing Education (ASPIRE)

Under the Surviving Spouses Scholarship Program presented by BAE Systems, Inc., ASPIRE provides scholarships to single parents who have lost a spouse in OEF or OIF. Scholarships may be used for tuition, books, utility bills, car maintenance, childcare or any other financial need that contributes to the recipient's success in school. In addition, counselors are available to serve as coaches and assist with day-to-day issues such as financial planning and tutoring.

Single parents selected for financial assistance will meet the following criteria:

- Widow/widower of a service member, between the ranks of E1-E9, who has died in action while serving in OEF or OIF.
- ➤ Be able to prove that your spouse was enlisted in the U.S. Military from 2001 to present.
- High School or GED graduate.
- ➤ Single head of household (single, legally separated, divorced, widowed) with sole custody of one or more children under the age of 21, and not co-habiting with ex or current spouse or partner.
- Pursuing a career-oriented course of study (full-time) to ensure a better standard of living for his/her family. Applicants cannot already have earned an undergraduate degree.

<u>Defense Commissary Agency Scholarships for Military Children Program</u>

The Scholarships for Military Children Program was created to recognize the contributions of military families to the readiness of the fighting force and to celebrate the role of the commissary in the military family community. Scholarships are available to dependent, unmarried children of active duty, reservists, National Guard or Survivors of a deceased member as long as the child has a valid military ID card. Applicants must be younger than 21 or 23 if enrolled as a full-time student at a college or university. Applications are normally available in early December. Dependents Education Assistance (DEA) Program

The Survivors' and Dependents' Educational Assistance (DEA) program offers education and training opportunities to eligible dependents of Veterans who are permanently and totally disabled due to a service- related condition or of Veterans who died while on active duty or as a result of a service-related condition.

Type of Assistance:

Benefits may be used for degree and certificate programs, apprenticeship, and on-the-job training. If you are a spouse, you may take a correspondence course. Remedial, deficiency, and refresher courses may be approved under certain circumstances. Get the <u>DEA pamphlet.</u>

Available Benefits and Eligibility

You may receive up to 45 months of education benefits. Effective Oct. 1, 2013, some DEA beneficiaries may be eligible for up to 81 months of GI Bill benefits if they use the Survivors and Dependents Educational Assistance program in conjunction with an entitlement from other VA education programs. View current payment rates. If you are eligible for both Fry Scholarship and DEA, you will be required to make an irrevocable election between the two programs when you apply. DRS Guardian Scholarship Fund

The DRS Guardian Scholarship Fund is provided for college-bound or enrolled children of National Guard men and women who have lost their lives in support of the war on terrorism. Applicants can apply for up to \$25,000 in scholarship funds from DRS Technologies, a New Jersey-based defense contractor. The Guardian Scholarship Fund is administered by the National Guard Educational Foundation (NGEF). Students will receive up to \$6,250 per year for four years if they attend a four-year institution and for those attending a two-year program at a community college or technical school, the scholarship will provide up to \$6,250 for both years. A review panel created by NGEF will determine who will receive the funds, which will be paid directly to the school. Juniors and seniors in high school, as well as students already in college, are eligible to apply. To date, eKnowledge has donated more than \$38 million of free test prep software to military families worldwide (note: there is a small charge for materials, processing and shipping, currently about \$17). They also offer significantly discounted prices on other educational programs. The free software comes in a single DVD and includes more than 11 hours of Virtual Classroom instruction and 3,000 files of supplemental test prep material. Entrepreneurship Bootcamp for Veterans' Families (EBV -F)

The EBV-F is an education and training program offered by the Whitman School of Management at Syracuse University. The program is designed to leverage the flexibility inherent in small business ownership to provide a vocational and economic 'path-forward' for military family members who are now caregivers to a wounded warrior – or for the surviving spouse of a military member who gave his or her life in service to our country. The EBV-F program will integrate training in small business management, with caregiver and family issues, positioning the family member to launch and grow a small business in a way that is complementary or enhancing to other family responsibilities.

Eligibility includes the surviving spouse or adult child of a soldier, airman, sailor, coast guardsman, or Marine (active, guard or reserves) who lost their life since 2001, as a consequence of their military service. The program is entirely free to accepted applicants including travel, lodging and meals. Folds of Honor Foundation (FHF)

FHF provides post-secondary educational scholarships for children and spouses of military service men and women killed or disabled while serving our great nation. Scholarships are to be used to subsidize the costs of tuition, school books, fees, room and board, special tools and equipment necessary for coursework, school-approved tutoring, and any other expense that the school in which the student is enrolled may deem appropriate and unmet. There are two available types of scholarships:

- ➤ Immediate-Use Scholarship: awarded to the spouses or dependents that are currently attending or recently accepted into a 4-year or 2-year degree program at an institution of higher education, OR a vocational, technical or other certification program.
- Future-Use Scholarship: awarded to the young children of service members, infants up to, and including, the 8th grade, and invested by the Foundation on their behalf, the scholarship is dispersed at the time of college enrollment.
 - To be eligible, an applicant must be the spouse or dependent of:
- An active duty or Reserve Component Soldier, sailor, airman, Marine, or Coast Guardsman killed or disabled in the Global War on Terror or other unique applications presented to and approved by the FHF board in writing on a case-by-case basis.
- An active duty or Reserve Component Soldier, sailor, airman, Marine or Coast Guardsman who is currently classified as a POW or MIA.
- > A veteran who died from any cause while such service-connected disability was in existence.
- A service member missing in action or captured in line of duty by a hostile force.
- ➤ A service member forcibly detained or interned in line of duty by a foreign government or power.

Marine Corps Scholarship Fund

The Marine Corps Scholarship Foundation is the nation's oldest and largest provider of need-based scholarships to children of Marines and Navy Corpsmen, with particular attention given to those whose parent has been killed or wounded in combat, or who have demonstrated financial need.

Applicants must the son or daughter of one of the following:

- Active duty or Reserve U.S. Marine who has served at least 90 days.
- Veteran U.S. Marine who has received an honorable discharge, medical discharge, was wounded, or was killed while serving in the U.S. Marine Corps.
- Duty or Reserve U.S. Navy Corpsman who is serving, or has served with a U.S. Marine unit.
- Veteran U.S. Navy Corpsman who has served with a U.S. Marine unit and has received an honorable discharge, medical discharge, was wounded, or was killed in the U.S. Navy. Heroes Tribute scholarships provide up to \$30,000 over four years to students who meet these eligibility requirements. Applicants must also meet the requirements listed above with the exception of the family income cap. Income requirements are waived for Heroes Tribute scholarships.

Heroes Tribute scholarships are for:

- ➤ The children of Marines, and of former Marines, who were killed in the terrorist attacks on 11 Sep 2001.
- ➤ The children of Marines, and Navy Corpsmen serving with them, killed in combat since 11 Sep 2001. For more information, go to www.mcsf.org or call 800-549-0060

Marine Gunnery Sergeant John David Fry Scholarship also known as: Post-9/11 GI Bill:

The Marine Gunnery Sergeant John David Fry Scholarship (Fry Scholarship) provides Post-9/11 GI Bill benefits to the children and surviving spouses of Service members who died in the line of duty while on active duty after September 10, 2001. Eligible beneficiaries attending school may receive up to 36 months of benefits at the 100% level. For more information on payment rates click here. For more information click here.

Eligibility: Children and surviving spouses of an active duty member of the Armed Forces who died in the line of duty on or after September 11, 2001 are eligible for this benefit. Children are eligible as of their 18th birthday (unless they have already graduated high school). A child may be married or over 23 and still be eligible, although their eligibility ends on their 33rd birthday. A spouse will lose eligibility to this benefit upon remarriage. A spouse has 15 years from the date of death of the Service member to use the benefit.

If you are eligible for both Fry Scholarship and DEA (Dependents Educational Assistance), you will be required to make an irrevocable election between the two programs when you apply. Dependents are not eligible to receive both DEA and the Fry Scholarship based on the same event (like a Service member dying in the line of duty) unless he or she is a child whose parent died prior to August 1, 2011. A child of a parent who died prior to August 1, 2011 may still be eligible for both benefits but he/she may only use one program at a time and combined benefits are capped at a total of 81 months of full-time training.
